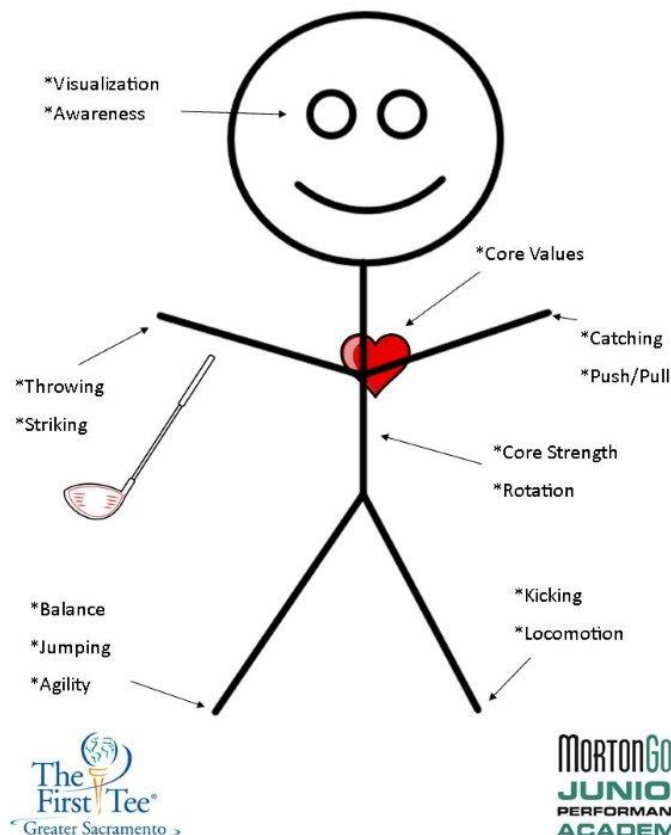

## MINOR WAIVER & RELEASE

In consideration for permission to participate in any of The First Tee of Greater Sacramento activity or event at Bing Maloney Golf Course or any other facility, specifically including but not limited to the use of all golf course, driving range and other practice areas, today and on all future dates, I, for myself, ***and on behalf of the minor child enrolling in this The First Tee of Greater Sacramento program or event***, our heirs, personal representatives and/or assigns, do hereby release, waive, discharge, and covenant not to sue The First Tee of Greater Sacramento, Morton Golf Management LLC, Morton Golf LLC and the City of Sacramento, their respective directors, officers, owners, employees, independent contractors or agents (collectively referred to herein as "The First Tee of Greater Sacramento"), from liability for any and all claims for personal injury, illness, death, property damage, or any other claim, including but not limited to claims arising out of the negligence of any The First Tee of Greater Sacramento-related entity including their employees and agents. This waiver and release of liability applies to all program or event activities, without limitation, regardless of whether it is self-guided or conducted by an instructor or coach.

It is expressly agreed that participation in any and all event or program activities, including but not limited to the use of all golf course and golf-related premises and facilities, without limitation and whether engaging in golf-related activities or not, shall be undertaken by the minor participant at his/her sole risk, and The First Tee of Greater Sacramento shall not be liable for any injuries or any damages to any minor participant, or the property of any minor participant, or be subject to any claim, demand, damages or causes of action arising out of the use of, or occurring on, the course premises or facilities regardless of whether it was caused by the negligence of The First Tee of Greater Sacramento. This waiver and release is intended to be as broadly interpreted as allowed under California law.

The Parent/Guardian executing this waiver and release of liability hereby agrees to hold The First Tee of Greater Sacramento and all related entities and individuals harmless from all claims which may be made by or on behalf of the minor participant enrolling in this event or program and to indemnify The First Tee of Greater Sacramento from any such claims to the fullest extent allowed under California law. This express indemnification provision specifically includes reimbursement for any and all attorneys' fees and litigation costs incurred by The First Tee of Greater Sacramento or on its behalf as a result of any such claim.

In consideration for permission to participate in this The First Tee of Greater Sacramento event or program I also grant, on my own behalf and on behalf of the minor attendee or participant, The First Tee of Greater Sacramento the right to use any image or photograph of the minor for promotional or other purposes. This release shall continue in perpetuity unless revoked in writing.

***The Parent/Guardian also expressly acknowledges that by signing below he or she is relinquishing all rights he or she may have to sue The First Tee of Greater Sacramento for injuries arising out of the use of the golf course premises and facilities that arise during the minor's participation in and presence at any The First Tee of Greater Sacramento-related program or event.***

***The Parent/Guardian also acknowledges that he or she is relinquishing, on behalf of the minor children participating in the event or program or using the golf course premises and facilities, all rights the child may have to sue The First Tee of Greater Sacramento for injuries arising out of the use of all facilities or services regardless of whether the injuries were caused by the negligence of The First Tee of Greater Sacramento or its employees or agents.***
